	We offer products from a range of insurers.

3. W	hich service will we provide you with?
	We will advise and make a recommendation for you after we have assessed your needs.
	You will not receive advice or a recommendation from us. We may ask some questions to narrow down the selection of products that we will provide details on. You will then need to make your own choice about how to proceed.
<u>4. V</u>	What you will have to pay us for our services?
	A discretionary fee of £5 for mid term adjustments, and a fee of £10 in respect of replacement / duplicate certificates or cover notes and mid term cancellations. No fee will be charged for new business, renewals or recovering uninsured losses from third parties on your behalf.
	With regard to policy cancellation, we also deduct the commission which the insurers "claw back" from us., from the refund.
	No fee.
You v	will receive a quotation which will tell you about any fees relating to any particular insurance policy.

5 Premiums

In most instances, premiums are collected by Green Campbell Fisk as agents of the insurer and risk transfer is said to have operated. This means that all monies paid or refunded are regarded as insurer monies on the basis the monies are in respect of insurance cover provided. Should in the unlikely event Royminster Ltd T/As Green Campbell Fisk be liquidated, your financial position is protected by the insurers.

For the rare case where risk transfer does not operate and Green Campbell Fisk are not authorised to act as agent of the insurer for the purpose of handling premiums, you will be asked to make payment of the premium direct to the insurer.

6. Who regulates us?

Royminster Ltd T ?as Green Campbell Fisk, 10 London Road, Bexhill-on-Sea, East Sussex, TN39 3JU is authorised and regulated by the Financial Services Authority. Our FSA register number is 308475.

Our permitted business is advising on and arranging non-investment insurance contracts.

7. What to do if you have a complaint

If you make a complaint in respect of a contract that is sold to you after 13 January 2005 and you cannot settle your complaint with us, you may be entitled to refer it to the Financial Ombudsman Service.

8. Are we covered by the Financial Services Compensation Scheme (FSCS)?

We have been covered by the FSCS since 14 January 2005. You may be entitled to compensation from the scheme if we cannot meet our obligations. This depends on the type of business and the circumstances of the claim.

Insurance advising and arranging is covered for 100% of the first £2,000 and 90% of remainder of the claim, without any upper limit.

For compulsory classes of insurance, insurance advising and arranging is covered for 100% of the claim, without any upper limit.

Further information about compensation scheme arrangements is available from the FSCS.

9. Confidentiality
