**Minutes of the Meeting of the British Chess Federation Council

**Mike Gunn** in the chair. The meeting opened at 16:48.

**1. Apologies, Proxies and Postal Votes**

These were available from John Philpott.

A **list of attendees** and their affiliations is given in **Appendix 1**.

**3. To Approve the Minutes of the Annual General Meeting of 12 October 2013**

As no points of accuracy were raised, the **Chairman** proposed:-

**4. Matters Arising Therefrom**

There were no Matters Arising.

**5. Accounts**

**David Eustace** presented the **BCF** accounts for the year ended 30 April 2011, the year ended 30 April 2012 and the 16 months period ended 31 August 2013. John Philpott had produced the accounts, resorting to what David Eustace characterised as “reverse engineering” as he had an incomplete set of records to work from. They had been sent to the auditors who had come back with some generally minor comments. There was a presentational issue over the treatment of realised gains, but that did not affect the balance sheets.

**Chris Priest** enquired whether the problems with the accounts had now gone away. **John Philpott** confirmed that they had, as there was now a proper ledger. Once the latest balance sheet was approved, things should run smoothly going forward. He hoped that at least an advance copy of the accounts for the current year would be available for the AGM in October.

**Motion: “that Council approves the accounts for the year ended 30 April 2011, the year ended 30 April 2012 and the 16 months period ended 31 August 2013”.**

**On a hand vote: Passed nem con**

**David Eustace** reported that the **Chess Centre Limited** accounts had been brought up to date. They were part of the Permanent Invested Funds. Geoff Steele, the company secretary, had died. There were 2 existing Directors, Gerry Walsh and Alan Martin. Alan wished to retire. The Board had decided to ask the Chess Centre Limited to appoint himself and John Philpott as Directors. The existing Directors would call a Meeting where these appointments could be made and Alan Martin could then retire.

The **John Robinson Trust** was not under the Board's control, but the trustees had produced their accounts. They had a healthy balance and a healthy income that they could distribute.

**Motion: "that Council notes the accounts of the Chess Centre Limited and the John Robinson Youth Chess Trust".**

## **6. The Permanent Invested Fund**

**David Eustace** announced that there were a couple of changes that the Board wanted to make compared to what was shown on the agenda. Regarding item 6.1, the Permanent Invested Fund (PIF) life terminates on 20<sup>th</sup> May 2014. It was decided to have a further period of consultation with regard to the PIF and the new charity that was to be set up and it was intended to extend the life of the PIF for 12 months, to 20<sup>th</sup> May 2015. That would give at least 2 further Council meetings to sort out what to do.

**Ray Edwards** suggested it would be better to extend the life of the PIF for 2 years to avoid time pressure, as things always took longer than expected. **David Eustace** was content with that suggestion and **Chris Majer** seconded it.

**Chris Priest** enquired what would happen if the term was not extended? **David Eustace** answered that the money would come back to the BCF.

**Motion: "that Council authorises the renewal of the Permanent Invested Fund until 20<sup>th</sup> May 2016 upon the terms of the Trust Deed set out in Schedule 3 and authorises Philip Charles Ehr to execute the same on its behalf (the schedule of Investments being updated as at the date of execution of the deed)."**

**On a hand vote:**

**David Eustace** reported that the Board wished to drop agenda item 6.2, on transferring funds to the Chess Trust, at this stage in favour of having a period of consultation with the membership to get feedback on the way forward for the new charity and the PIF.

**David Thomas** reflected on the discussion that had taken place at the Board meeting and noted that it might have been him who had triggered the decision to postpone a decision on transferring the money. He had a directed proxy vote to cast against the original proposal. The reasoning was that once the money had been moved to the charity it could only be used for charitable purposes, whereas if it was left in the PIF or moved in a different direction, it could be used to support the international teams and suchlike. The question was what sort of balance should be struck between those two objectives, and that was the point of the consultation to ask people what they'd like to do with the money in the PIF.

**Andrew Leadbetter** asked whether members of the ECF Council who were not part of the BCF Council could take part in the consultation. **David Eustace** agreed with them doing so as it would be useful to get their views even if they couldn't vote on it.

As agenda item 6.2 was withdrawn, there was no vote on transferring money from the PIF, but Council noted that there would be a period of consultation.

**7. Any Other Business notified to the Chairman before the start of the meeting.**

There were no items of Any Other Business.

The **Chairman** closed the meeting at 17:03.
