#### 7. Home Directors report (AH)

The report was discussed and approved. If Birmingham is successful in its bid to host the Commonwealth Games in 2022, we hope to hold the Commonwealth Chess Championships too.

## 8. Payments to FIDE Arbiters etc. (AH)

FIDE fees for arbiters are due to be paid totalling £1098. It was proposed the ECF should pay these fees, as ultimately it is the Federation who benefits.
