The British Chess Federation Council meeting minutes of the 24 June 2006 which considered the Deed of Variation state: That the Trustees be requested:

- (i) To retain the capital of the Trust as a permanent endowment and not to expend more than the accumulated income on grants from the Trust.
- (ii) To give three months prior written notice to the BCF Management Board of any proposed expenditure of capital

The Trust has been following the above request since 2006 as can be seen in the annual report and accounts prepared each year. It would be helpful to the Trust for this request to be rescinded.
