1. Appointment of Chairman

The Chairman was present for the start of the meeting.

2. Notices

Representatives were directed to the ECF website for the formal notices.

3. Approval of the Minutes of the 22 April 2022 Meeting

Council resolves that the Chair of the meeting shall sign the minutes of the last Finance Council meeting on 22 April 2022 as being an accurate record.

4. Matters Arising from the Minutes

There were no matters arising.

5. Accounts of the BCF for the Year Ended 31 August 2021

The accounts of the BCF for the year ended 31 August 2021 were accepted. There were no votes against.

6. Accounts of the BCF for the Year Ended 31 August 2022

The accounts of the BCF for the year ended 31 August 2022 were accepted. There were no votes against.

The 2022 accounts would show assets being transferred out to the Chess Trust. The BCF would not be wound up as a precautionary measure, because there were bequests held in the name of the BCF and the small cost of keeping a dormant organisation going was felt to be prudent.

9. Update on the Activities of the John Robinson Youth Chess Trust

The report from the Chairman of the John Robinson Youth Chess Trust had been uploaded to the ECF website prior to the meeting.

Whilst discussing the activities of the JRYT and the possibility that the ECF might apply for a payment to go into its Bursary fund to be used to support junior players, it was agreed that the ECF would add a link to the soon to be launched JRYT website to its own website and that it would also add further sources of potential funding and support.

The British Chess Federation Council meeting minutes of the 24 June 2006 which considered the Deed of Variation state: That the Trustees be requested:

- (i) To retain the capital of the Trust as a permanent endowment and not to expend more than the accumulated income on grants from the Trust.
- (ii) To give three months prior written notice to the BCF Management Board of any proposed expenditure of capital

The Trust has been following the above request since 2006 as can be seen in the annual report and accounts prepared each year. It would be helpful to the Trust for this request to be rescinded.

The meeting agreed to this change with 26 in favour and none against.

10. Update on the Activities of the Chess Trust

David Eustace said that the Chess Trust had been formed ten years previously and the current Trustees were Simon Brown, Stephen Greep, Sarah Longson, Malcolm Pein, Adam Ashton, Mike Truran and himself. There was currently around £900,000 held split into three funds – the Junior fund, the General fund and the British Chess Championships fund. This year The Chess Trust was supporting the British Chess Championships with a donation of £10,000, £45,000 on its Accelerator Programme for aspiring junior players, £6,000 to the ECF Awards Committee to be spent over the next three years, £10,000 to help Ukrainian refugees and several grants to support "norm" tournaments, Women's events and Senior Chess teams. The Trust also retained £100,000 as a financial contingency for the ECF against events such as the recent pandemic.

11. Any Other Business

There being no further business the Chairman closed the meeting.
