# 4. Minutes of the 14th October 2023 Annual General Meeting

Council resolves that the Chair of the meeting shall sign the minutes of the Annual General Meeting of 14<sup>th</sup> October 2023 as being an accurate record.

The minutes were agreed nem con, and it was agreed that the Chair would sign them.

#### 5. Matters Arising

There were no matters arising.

#### 6. Annual Accounts and Finance Director's Report

- (i) The Finance Director presented the draft accounts for the ECF for the year ended 31st August 2023 and explained the following key points:
  - The auditor had raised no issues with the accounts.
  - The loss for the year was £7k against a planned profit of £19k giving an adverse variance of £26k.
  - Referring to the balance sheet, a cash balance of £220k and reserves of £77k were held, which provides a good position with which to meet any short-term financial shocks.

The accounts for the year ended 31st August 2023 were accepted nem con.

- (ii) The Finance Director presented his report for the year ended 31<sup>st</sup> August 2023 and explained the following points:
  - The ECF has received a grant of £500k over two years from DCMS: £250k ending March 2024 and £250k ending March 2025.
  - The grant is for incremental expenditure over and above the normal budget.
  - The grant is to be spent on international chess initiatives and elite players.
  - Although it is hoped that the grant will be repeated in future years it is not guaranteed, therefore future years' budgets are currently constructed assuming no further grants.
  - On membership rates an increase of £2 pa across all categories is proposed alongside the amalgamation of the Silver and Gold categories. This should provide additional revenue of £11k for this year and £22k in future years.

The report was noted and agreed nem con.

# 8. Membership Fees

The Board had proposed a set of new membership fees as given in the agenda. There was much discussion on several of the proposed fees and the following amendments were proposed:

a) The new combined Silver/Gold category fee should remain at the £33 instead of the proposed rate of £35 pa. Proposed by Gavin Cartwright, seconded by John Reyes.

Result: In favour 5. Against 20. Amendment failed.

b) The Bronze membership fee should remain at £18 instead of the proposed £20 pa. Proposed by David Gilbert

Result: In favour 7. Against 20. Amendment failed.

c) That a Junior Bronze membership should be included in the membership rates which would be free in the first year and at £6 p.a. thereafter. Proposed by Nikki Forster, seconded by David Gilbert

Result: In favour 16. Against 12. Amendment passed. A card vote was called.

d) Card vote: That Council amends the membership fee table in the agenda to add a Junior Bronze membership fee: free in the first year and £6 p.a. thereafter, and to add a junior non-members Bronze game fee of £6.

Proposed by Nikki Forster, seconded by David Gilbert

Result: In favour 98. Against 88. Amendment passed.

Vote on membership fees detailed in the tables below as proposed by the Board and amended for item 8 (d) above.

Result: in favour 27, Against 3. Motion passed.

Consequently, the fees below will be effective from 1st July 2024.

### 9. Budget

The budget for 2024/25 as set out in the Finance Director's documents was accepted nem con.

#### 10. Report of the Chair of the Finance Committee

Nick Faulks added to his report that the financial position was satisfactory and that the Finance Director had kept him abreast of events. The grassroots budget will be discussed at the next Board meeting.

The report was noted.

#### 11. Presentation on the Use of the Grant from the DCMS

Malcolm Pein presented a very useful explanation of the grant which the ECF has received from the DCMS. The presentation is included in the papers for the meeting and those with an interest should refer to that document.

#### 12. Rolling Membership Resolutions

(i) This resolution was proposed as a special resolution:

THAT the articles of association of the ECF be amended by deleting the existing wording of article 18 (5) and replacing it with "Determination of the Membership Fee to be charged for each category of Direct Member for membership periods commencing between 1<sup>st</sup> September next, (or, if Council so determines in any year, an earlier date up to two months before to be determined by the Board), and 31<sup>st</sup> August of the following year.

Vote. The resolution was passed nem con.

(iii) The following resolution was proposed as an ordinary resolution:

THAT The Direct Members Bye Laws be amended by:

- (a) deleting the second paragraph of clause 2 and replacing it with the following: "The membership period in respect of a new Direct Member, or an existing Direct Member renewing for a higher category of membership, shall be for a period of 12 months commencing on the first day of the calendar month in which they join or, as the case may be, renew. The membership period for a renewing member for the same or lower category of membership shall, provided that renewal is effected no later than one month after expiry of their then current membership, be for a period of 12 calendar months commencing immediately on expiry of the expired membership period. If renewal is not effected within such one month period, then the application for membership shall be treated in the same way as an application by a new Direct Member."
- (b) replacing all references, whether capitalised or not, to "grading" or "graded" to "rating" and "rated" respectively; and
- (c) deleting the schedule to the Bye Laws.

Vote: The resolution was passed nem con.

# 12. Amendment to Implement Abolition of Organisation Membership Fee and Having Clubs as Members

The paper entitled "Proposals to Extend Club Representation, Abolish Council Membership Fees, and Update Council Membership Arrangements" explained the changes proposed by the Board for the abolition of the organisation membership fee and the mechanism for allowing clubs as members.

The following resolution was proposed as a special resolution:

THAT the articles of association of the company be amended as set out in the marked-up draft articles of association signed by the Chair of the meeting for the purposes of identification.

Vote: In favour 25. Against 1. Motion passed.

#### 13. Amendments to Procedural Bye-Laws

The following proposals to amend Bye Law No 3 (Procedural Bye-Laws) were presented:

The amendments were agreed nem con.

- (a) deleting the last sentence of paragraph 2.1 and replacing it with "For the purposes of this paragraph 2.1 if a meeting is held virtually, it shall be deemed not to have taken place for the purposes of the operation of the meetings cycle.
- (b) deleting sub-paragraph (a) of paragraph 12.6 (and re-lettering the existing sub-paragraphs (b) and (c) accordingly); and
- (c) in paragraph 12.7, deleting the wording from "indicating" to the end and replacing it with "...indicating the Post for which they are nominated and the name of their proposer or proposers but only the proposer or proposers that sufficed for the candidate to be duly nominated."

#### 14. Grassroots Chess Initiatives

The Director of Home Chess explained the Board's proposals on the use of the funds for grass roots chess which are contained in the agenda papers by the Director of Home Chess.

## 15. Any Other Business

No further items were raised.
